Gentlemen:

In accordance with the recorded request of the subject-named service member or his insurance company and/or other information received, there is enclosed herewith a Certification of Casualty, DD Form 1300, for use in the adjudication of insurance claims arising out of the death.

By agreement with the International Claims Association, a Certification of Casualty usually is considered acceptable evidence of death of the service member and reflects the current address of the next of kin.

If additional information is required in the case of death from natural causes (disease), inquiry should be made to the Bureau of Medicine and Surgery, (Code 3373), Department of the Navy, Washington, D. C. 20390. When additional information is required concerning circumstances of death from accidental or violent causes, inquiry should be addressed to the Office of the Judge Advocate General, Department of the Navy, Washington, D. C. 20390. The request should include the full name and grade or rating of the service member, his file or service number, and the written authorization of his primary next of kin for the release of the information.
