 RMKS/1. ON 15 MAY 95, THE VIETNAMESE GOVERNMENT TURNED OVER THREE SETS OF DOCUMENTS RELATING TO U.S. LOSSES IN SOUTHEAST ASIA. ONE SET OF DOCUMENTS CONTAINED A REPORT TITLED: "REPORT ON RESULTS OF OPERATIONS OF THE MINISTRY OF INTERIOR'S (MOI) SPECIAL INFORMATION SEEKING GROUP." THIS REPORT INCLUDED TEN DOCUMENTS. THE SECOND SET OF DOCUMENTS WAS A REPORT FROM THE MINISTRY OF DEFENSE (MOD) MIA SPECIALIST TEAM TITLED: "REPORT OF RESULTS OF UNILATERAL OPERATIONS TO COLLECT MIA INFORMATION AND DOCUMENTS." THIS REPORT INCLUDED THREE DOCUMENTS. THE THIRD SET OF DOCUMENTS WAS A VIETNAM OFFICE OF SEEKING PERSON (VNOSMP) ASSESSMENT OF THE 84 SPECIAL REMAINS TEAM (SRT) CASES.
 2. THE MOI REPORT, "REPORT ON RESULTS OF OPERATIONS OF THE MOI'S SPECIAL INFORMATION SEEKING GROUP" DETAILS A 4 - 12 MAY 95 EFFORT BY THE MOI TO SEARCH FOR POW/MIA INFORMATION IN VINH PHU, TUYEN QUANG, YEN BAI, HOA BINH, NINH BINH AND THANH HOA PROVINCES. THE REPORT BRIEFLY DESCRIBES DOCUMENTS AND SKETCH MAPS RECOVERED AND/OR PHOTOGRAPHED IN THE VARIOUS PROVINCES BY THE SPECIAL INFORMATION SEEKING GROUP. ONE OF THE DOCUMENTS WAS TITLED, "LIST OF AMERICANS MISSING

THE DOCUMENT IS A LETTER FROM THE DEPUTY CHIEF OF AN UNSPECIFIED THANH HOA PROVINCE OFFICE, AND CONTAINS A LIST OF 17 LINE ITEMS INDICATING 17 AMERICANS WHOSE REMAINS WERE EXHUMED, FOUND, OR SOLD IN THANH HOA PROVINCE. IT IS DATED 3 JUL 91. THE DOCUMENT PROVIDES LIMITED CASUALTY-RELATED INFORMATION. JTF-FA ANALYSTS HAVE IDENTIFIED LINE ENTRIES POSSIBLY CORRELATING WITH THE FOLLOWING UNRESOLVED CASES: 0095-0-01, 0103-0-01, DATA 0550-0-01, 0449-0-01, 0351-0-01, 0578-0-01, DATA DATA 0090-0-01, 0067-1-01, AND 0628-0-01; AND THE FOLLOWING RESOLVED CASES: 0457-0-01, 0093-1-02, 0093-1-03, 0093-1-01 AND 0138-0-01. EACH OF THE 17 LINE ENTRIES CORRELATES BY NAME WITH A KNOWN LOSS INCIDENT. IT SHOULD BE NOTED, HOWEVER, THAT THE DOCUMENT APPEARS TO BE A CONSOLIDATED LIST OF CASES WHICH, ACCORDING TO U.S. RECORDS, TOOK PLACE IN THANH HOA PROVINCE, AND TO BE BASED ENTIRELY UPON NARRATIVES PROVIDED TO THE SRV BY THE USG AT VARIOUS TECHNICAL MEETINGS. THANH HOA PROVINCE OFFICIALS APPARENTLY PREPARED THIS DOCUMENT TO ASSIST THEIR EFFORTS TO RECOVER AMERICAN REMAINS, AND IT REMAINED IN THEIR FILES AT THE TIME OF THE MOI TEAM'S VISIT.

THE HAMLET IS NOW CALLED KIM DE. THIS MAY ACCOUNT FOR THE PARENTHETICAL QUESTION MARK PLACED AFTER THE TOPONYM BY THE COMPILER OF THE DOCUMENT. IT APPEARS THAT THE SRV OFFICIALS IN THIS CASE WERE BASING THEIR WORK ON INFORMATION THE USG PROVIDED.))

THE INFORMATION THAT THE PILOT MIGHT HAVE BEEN BURIED AT MY LAM WAS PROVIDED TO THE SRV BY THE USG, WHICH PROBABLY ACCOUNTS FOR THE PARENTHETICAL QUESTION MARK PLACED AFTER THIS TOPONYM. THE INFORMATION ABOUT THE BURIAL SITE HAS SUBSEQUENTLY BEEN CORRELATED WITH A RESOLVED CASE.))
